

## **AWARD AND CRITERIA FOR NOMINATION**

### **EXTRA EFFORT**

This is directed to a newer member.  
Participates on at least one State Committee.  
Assumes tasks and goes beyond what is asked.  
Demonstrates the ability to be creative and motivated.

### **RISING STAR**

Participation on more than one State Committee.  
Currently or in the past, chaired a State Committee.  
Demonstrates leadership skills.  
Demonstrates a desire to increase knowledge.

### **FOUNDERS**

Involvement at State level for more than 5 years of service as a Governor, Officer or Committee Chair.  
Participation on several committees.  
Chaired several committees.  
Continued involvement in WCR, offers to help and mentor.

### **AFFILIATE OF THE YEAR**

Has been involved at the State Level for three years or more.  
Participation on three State committees, currently or cumulatively.  
Exemplifies the objectives of WCR through willingness to lend a helping hand.

### **HONOR CIRCLE - LOCAL CHAPTER**

An outstanding member of WCR for two years or less as of July of current year.

### **MEMBER OF THE YEAR - LOCAL and STATE CHAPTERS**

Shall have been a member for a minimum of 5 consecutive years  
Officers are ineligible during or within one year after term of office .

### **CHAPTER OF THE YEAR**

This award will be presented to the LCP who's Chapter best exemplifies the leadership qualities necessary to achieve the goals of WCR.

## **SUBMISSION REQUIREMENTS**

May be submitted by State Leadership, including Committee Chairs.

May be submitted by Local Chapter Presidents or Local Chapter Awards Chairman, State Line Officers, Governors or District Vice Presidents.

May be submitted by Local Chapter Presidents or Local Chapter Awards Chairman, State Line Officers, Governors or District Vice Presidents.

May be submitted by Local Chapter Presidents or Local Chapter Awards Chairman, State Line Officers, Governors or District Vice Presidents.

Honor Circle is nominated by the Local Chapter.

Member of the Year is nominated by the Local Chapter  
Local Chapters may have both a local and State Member of the Year .

Must be submitted by State Line Officers, District Vice Presidents or Governors.

**DISTRICT VICE-PRESIDENT OF THE YEAR**

A member who has served as a District Vice President and has shown outstanding leadership qualities in leading the chapters in her/his District.

Must be submitted by State Line Officers, District Vice Presidents or Governors.

**MENTOR OF THE YEAR**

Member who has gone the extra mile in giving of their time and talent in working and mentoring members through the leadership process. This member must have served as at least one of the following: an officer, a committee chairman, governor, or a DVP.

May be submitted by Local Chapter Presidents or Local Chapter Awards Chairman, State Line Officers, Governors or District Vice Presidents.

**GOVERNOR OF THE YEAR**

Member who has served as a Florida State Governor and has shown outstanding leadership abilities in dealing with the districts and chapters in the assigned territory.

Must be submitted by Local Chapter Presidents, District Vice Presidents, or State Line Officers.

**HUMANITARIAN**

Person to be considered should be a member in good standing. The nominee should have freely given of their time and talents to one or more organizations. This person should have volunteered many hours of service, commitment on a continuous basis and provided "hands on" involvement to a specific cause. This member, by way of example, is a role model for others.

May be submitted by Local Chapter Presidents or Local Chapter Awards Chairman, State Line Officers, Governors or District Vice Presidents.

### **ENTREPRENEUR OF THE YEAR**

Guidelines as set forth by National Women's Council of Realtors.

May be submitted by Local Chapter Presidents or Local Chapter Awards Chairman, State Line Officers, Governors or District Vice Presidents.

The Local Chapter Entrepreneur of the Year Award is awarded to a chapter member who has exhibited business leadership in their work and community. (While Member of the Year is awarded to a volunteer who has made a notable contribution to the life of the chapter, the Entrepreneur of the Year is awarded to a REALTOR® who has achieved something notable in business.)
